2025 Ballot for CSBA Delegate Assembly — U.S. Postmark Deadline is Mon. March 17

Enclosed is the ballot material for election to CSBA's Delegate Assembly from your region or subregion. It consists of: 1) the ballot (on red paper) listing the candidates, the reverse side of which contains the names of ALL current members of the Delegate Assembly from your region or subregion; and 2) the required candidate biographical sketch form and, if submitted, a resume. In addition, provided is a copy of the ballot on white paper to include with your board agenda. Only the ballot on red paper is to be completed and returned to CSBA. It must be postmarked by the U.S. Post Office on or before Monday, March 17, 2025.

Your Board may vote for up to the number of seats to be filled in the region or subregion as indicated on the ballot. For example, if there are three seats up for election, the Board may vote for up to three candidates. However, your Board may cast no more than one vote for any one candidate. The ballot also contains a provision for write-in candidates; their name and district or county office must be clearly printed in the space provided.

The ballot must be signed by the Board President, Board Clerk, or Superintendent as a designee of the board, and returned in the enclosed envelope; if the envelope is misplaced, you may use your district's or county office's stationery. Please write **DELEGATE ELECTION** prominently on the envelope along with the region or subregion number on the bottom left corner of the envelope (this number appears at the top of the ballot). If there is a tie vote, a run-off election will be held, and ballots will need to be postmarked on or before April 30. Results will be published by May 11, 2025.

For County Boards of Education Only:

Per Standing Rule 52, in regions with more than one county, each county board of education has one vote to elect the county board member who represents the county board(s) in the region in the Delegate Assembly. One-county regions will appoint the county Delegate. Your county board may vote for only one candidate to fill the Delegate position representing the county boards within your region. Enclosed is the ballot material for election to CSBA's Delegate Assembly of the county board representative from your region. It consists of 1) the ballot (on GREEN paper) listing the candidates, the reverse side of which contains the name of the current member of the Delegate Assembly representing the county boards in your region; and 2) the required candidate biographical sketch form and, if submitted, a resume. In addition, also provided is a copy of the ballot on white paper to include with your board


agenda. Only the ballot on GREEN paper is to be completed and returned to CSBA. Like the ballot on red paper for the other Delegate seats in your region, it must be postmarked by the U.S. Post Office on or before Monday, March 17, 2025.

The ballot on GREEN paper must be signed by the Board President, Board Clerk, or by the County Superintendent, as a designee of the board, and returned in the enclosed envelope. If the envelope is misplaced, you may use your county office's stationery. Please write **DELEGATE ELECTION** prominently on the envelope along with the region number on the bottom left corner of the envelope (this number appears at the top of the ballot). If there is a tie vote, a run-off election will be held, and ballots will need to be postmarked by April 30. The results for the county board seat in each region will also be published by May 11, 2025.

All re-elected and newly elected Delegates will serve two-year terms beginning April 1, 2025 – March 31, 2027. The next meeting of the Delegate Assembly takes place on Saturday, May 17 and Sunday, May 18, 2025. 11. Why are you interested in becoming a Delegate? Please describe the skills and experiences you would bring to the Delegate Assembly. *

First and foremost, I am a proud veteran of our U.S. Army Active Duty and have acquired excellent leadership skills as a young Army Ranger, serving our country. In addition, I also came to the USA, with my mom, as a German immigrant. I was also raised in many places in the world during my school years as a military brat; my K-12 education consisted of at least 8 different schools, in three different countries (USA, Germany, and Panama). During this time, I have made long-lasting friendships with many diverse people from all over the world. I feel that this skill set is much needed in our heterogenous culture, as we have students from all over the world, in our schools. I've had the pleasure of many great experiences and learning opportunities provided by CSBA and its staff. This has broadened my horizons in terms of interacting with other school board members and superintendents of various diverse backgrounds. As a result of this, I would use this opportunity as a CSBA delegate to become an ambassador to other board members, encouraging them to learn more about their roles as board members, no matter what their experience levels, so that they could continue to serve their students, in positions of leadership in their respective school districts.

I attended the CSBA Coast 2 Coast trip in 2023 and learned how to advocate and lobby for federal funds for our School District, at the state level. My emphasis here was specifically SPED, but even more specifically funding to enhance our G.A.T.E programs, which often lack attention, funding, and adequate bandwidth to give our students proper growth so that they can flourish in this area. I've also attended and completed the C.S.B.A.'s Masters in Governance (M.I.G.) class, in Aug. – Dec. 2023, and secured my certificate of completion. This experience gave me a deeper understanding of my role as a board member in terms of Foundations of Effective Governance, Student Learning and Achievement, Policy & Judicial Review, School Finance, Human Resources, Collective Bargaining, Community Relations & Advocacy, and Governance Integration.

In addition, I also attended CSBA's Annual Education Conference (AEC), in Dec. 2023. One of the highlights here was attending the Board President Workshop, to help sharpen my skills as a board president, making sure every voice was heard, even with our previously divided board

12. Please describe your activities and involvement on your local board, community, and/or CSBA. *

As a board member and a two-time elected President of TVUSD, I have had the honor of serving in a leadership capacity within our district. Throughout my tenure, I have maintained a 100% attendance record at board meetings, ensuring I am always present and engaged in person. In addition to my board responsibilities, I have actively participated in several subcommittees, collaborating with teachers, students, and district staff to address critical issues and initiatives.

One of the highlights of my service has been taking a leadership role in developing a new and more robust mission, vision, and values for our district. This effort was particularly significant because it marked the first time TVUSD established a formal vision statement. The process was highly collaborative, with our board working together diligently, one meeting at a time, to create a shared vision that reflects our district's goals and aspirations. Additionally, I have served on our local school board – city council subcommittee, fostering stronger partnerships and identifying ways to better serve our community's needs.

Beyond my work on the board, I am deeply committed to serving my local community. I have volunteered as a coach for youth soccer and basketball and served as a Trail Life leader, mentoring and supporting young people. I was also a founding board member of a nonprofit organization dedicated to advocating for better and newer skateparks in Temecula. This advocacy resulted in the city's approval and upcoming construction of a \$3.2 million skatepark, a significant investment in our youth and community resources.

My involvement in these diverse roles reflects my dedication to improving our schools, supporting our students, and strengthening our community.

13. What do you see as the biggest challenge facing governing boards and how can CSBA help address it? *

The biggest challenge I see facing governing boards right now is the impact of the new California state budget on our Local Control and Accountability Plan (LCAP) funding. This year's state funding is significantly lower than the previous year, which presents both challenges and opportunities.

For me, it's an opportunity to grow and take a deeper dive into understanding the LCAP and the state budget at a more advanced level. With a more refined knowledge, I can better advocate for increased funding for our students while ensuring we maintain competitive retention of our certificated teachers and classified staff—all while staying fiscally responsible.

CSBA can play a vital role in addressing this issue by providing training, resources, and advocacy tools to help board members navigate budget challenges, develop strategic funding plans, and effectively communicate the needs of their districts to policymakers.
