Dear Ana,

Please find attached the apparent responsive and responsible low bidder for the above-mentioned project, along with a schedule of all bids received.

In our review of the bids and post bid interviews, it was communicated by the low bidder, ARGEE Construction Inc., dba. Craftsman Construction that they were unable to receive a sub-bid for the Energy Management System. The contractors listing of subcontractors does not include a licensed mechanical contractor who would be necessary to perform this work. The provision for providing the EMS system was a requirement of the scope of work for all bidders. We deem this to be a material deviation from the bid document requirements and therefore non-responsive. This low bidder has not submitted a withdrawal letter.

As you are aware, we received a formal bid protest letter from the third-place contractor JM Builders, Inc along with subsequent rebuttal letters to the protest from ARGEE Construction and Roadway Engineering & Construction Inc. JM Builders was protesting award to both the low bidder and second lowest bidder.

Upon review of the protest letter / rebuttal letters, and concurrence with District's legal counsel, we feel it is in the best interest of the project for the School Board to award the contract for the project to Roadway Engineering & Construction Inc.

We have verified the low bidder's California contractor's license number, license classification and expiration date, along with current DIR registration. This contractor, along with their listed subcontractors, are currently licensed and registered per the requirements of the contract documents. Additionally, both they and their listed subcontractors meet the district's pre-qualification requirements.
